They've just confiscated Shane's laptop and are even searching his phone. The FBI actually raided an attorney Schulte was conferring in Texas named Dan Hurley--- They took Schulte's bail application claiming it was classified and the lawyer's possession of it a violation of the espionage act. So to be frank I can't get Shane to contact you directly but hopefully you can still help. The purpose of the articles was always to publish them and Schulte has arranged wordpress sites where he will be directing posts soon considering his 1 year anniversary since arrest:

We just need these 9 articles (we have pieces of the 10th and last) to finalize the site, but since Shane Presnall is under intense pressure (and all for what? It's incredible how they are targeting all his family) I'm hopeful you can help complete his and Schulte's goals for publication (even though a lot of it has already been posted).

Article 8: subtitled Origins

My case involves Wikileaks and the Vault 7/8 release. I worked for the National Security Agency and then the Central Intelligence Agency up through the end of 2016... I reported numerous security vulnerabilities that I discovered within our network and particularly issues with system administration, backup, and protection of some of our prominent tool sets... it did not matter that the search warrant provided no direct evidence of my involvement and in fact no evidence that linked my house or any of my devices to the alleged crime; In fact, it did not matter that all the probable cause used against me was entirely wrong and fabrications that the FBI refuted themselves in subsequent search warrants.... I can assure the American people that the single greatest threat to liberty and freedom is not ISIS or some other distant threat, but the federal government itself and the corrupt judicial system that hypocritically feigns moral superiority.



Article 9: subtitled The Devil's Dishonest, Deplorable Diabolically Demented Demons x3

"Let's go, get up." ... "Come on, you're going to jail." Wha? Is this another nightmare?...

[REDACTED] And so I was directed to federal prison for the remainder of my case up through trial. I'll spend my trial-- the determination of my guilt or innocence-- in federal prison presumed guilty.

I also have material information as I alluded to earlier--about a link between a Russian Oligarch and Trump's personal attorney Mark Kasowitz and a \$180 Million wire transfer from the same Russian oligarch to current US Attorney Geoffrey Berman's (and Giuliani's former law firm Greenberg Traurig) Its explosive as it unearths a dangerous trend as to what's really behind Putin's infrastructure attacks on the US. And it involves money.

Finally I think I can setup a direct line over Signal with Schulte in the coming days or weeks if you'd be interested?

I can send snippets of text of the two articles 8 and 9 that weren't released publicly to verify my identity with access to Josh and Shane.

This will assist Shane as he is under intense scrutiny now and cannot risk sending anything so he gave me your contact to retrieve the articles. We have other information to share regarding reiderstvo, russian attacks on US political and judicial systems (articles with multiple sources) as well as links between putin and his oligarchs to trump via Marc Kasowitz (emails, secure communications) and examples of other people targeted and arrested on behalf of the oligarchs for financial reasons..

I also have direct access to Josh that I can route communication. He tried to submit the visitor form you sent but the MCC is denying him any visits or communication to anyone outside especially the press.
